Call for Proposals

2020 GRANTS IN CRITICAL REFUGEE STUDIES

For University of California Faculty

Grant period: January 2020 through December 2020

Application deadline: by 5:00pm (PDT), Monday, October 28, 2019

The UC Critical Refugee Studies Collective (CRSC) invites grant proposals from UC-affiliated faculty working on scholarly, activist and/or creative projects that focus on refugees. We seek projects that center refugee perspectives, agency, and epistemologies. We are especially interested in funding projects that engage communities as partners and/or involve refugee populations of California.

Funded by the University of California Office of the President (UCOP), the CRSC is a four-year initiative (2017-2020) committed to making the University of California the premier institution for critical refugee teaching, research and public initiatives. The CRSC seeks to promote projects

that trace the impact of colonialism, imperialism, and militarization on refugee movements and that integrate scholarly, policy, and artistic interests with refugees' everyday concerns.

Topics/Themes

Over the four years of our annual grant cycles, we are exploring four different themes: time and space; land and water; secrets and stories; and wellbeing and resilience (sanuk/sumud).

In this fourth grant cycle, priority will be given to projects that focus on the theme: Wellbeing and Resilience or Sanuk (Thai) and Sumud (Arabic); we welcome all proposals that shift the reference point in refugee studies from that of the state, humanitarian organizations, and policy makers to that of the refugees. In this challenging time when, more than ever, refugees and immigrants are seen as political threats and social burdens to be barred, quarantined, and deported, this year's thematic emphasis on wellbeing and resilience is aimed at directing the gaze onto the humanity of the globally displaced, their fortitude, sacrifices, and contributions to their places of encounter. Towards these ends, we are particularly interested in projects that center, celebrate, and advance this vision of cohesive, healthy families and communities, and that critically engage the notions of wellbeing and resilience in their complexity, both in terms of what they make possible, as well as what they preclude.

Grant Amount

Maximum amount of each award is \$10,000. The grant can be used to complete an entire project, to provide seed money to start a larger project, or to accomplish smaller tasks of a larger project. (Projects that integrate faculty collaborations with artists or community organizers are also possible. For details, please see the CRSC Call for Proposals for Artists and Community Organizations.)

Faculty can request funds for summer salary, GSR funding, research travel, books, and/or other research-related expenses. Faculty can also request funds for replacement costs for a partial course release with benefits included, contingent on approval of the department chair and/or dean at the faculty's institution.

Due to the competitive selection process, the final amount awarded may vary and not be based on the proposed budget. All funds must be spent by December 31, 2020.

Restrictions

Candidates may apply to only one of the CRSC grant initiatives in the same funding cycle. Competitive candidates who do not receive funding for this cycle are encouraged to reapply in future cycles.

Grant monies cannot be used for the purchase of computer equipment, books, and/or any other materials for personal use. Purchases of equipment and other materials for the project must be pre-approved and will be considered the property of the University of California.

Eligibility and Requirements

All research involving human subjects must be reviewed by the Office for the Protection of Human Subjects (OPHS) to ensure the protection of participants' rights and welfare in the research process.

Outcomes

All grantees will be expected to submit a progress report of approximately two pages, due in July 2020 documenting the work they are conducting with the grant. Grantees will also be expected to present their work, whether completed or in-progress, at a conference planned for Fall 2020 at UC Berkeley. A final report must be submitted soon after the conclusion of the term of the grant.
